# Letter from the President



Dear League,

I hope this finds you healthy and well. It's been a rough June so please remember to take care of yourselves and each other.

Happy July! This 4<sup>th</sup> of July I am strengthened by all of you who continue to co-create our democracy. We will continue to use our collective power to demand our fundamental rights and freedom. We still have work to do, and I am thankful for all of you dedicated to making our democracy work and hearing every voice.

We faced another school shooting by rallying together against gun violence. Our power worked! President Biden signed into law a bipartisan gun bill, the first one in over three

decades. And, we have more to do.

We faced the devastating overturn of Roe v. Wade by SCOTUS. This decision is stripping away our reproductive rights and equality. In anger, hurt and power we showed up to rally for our reproductive freedom.

We received good news; a Leon County judge ruled that HB5, Florida's 15week abortion ban is unconstitutional and violates the privacy provision in our State Constitution and supports a temporary statewide injunction.

And the bad news: Governor DeSantis' office stated they will appeal the ruling and ask the Florida Supreme Court to reverse its existing precedent regarding Florida's right to privacy. We still have work to do.

Linsey Grove, Stacey Kroto and I were able to attend the LWVUS convention. It was inspiring to see over 1,000 people from all 50 states and Washington DC committed to empower voters and defend democracy. We debated, we discussed, we dug into the details of making democracy work and shared best practices when we face misinformation, disinformation and polarization. Florida was responsible for adding two items to the program: support for ERA and elevating direct voting through National Popular Vote (NPV) and abolishment of electoral college by amendments. This is in part thanks to our own NPV team!

Luckily, we did have celebrations too! We celebrated Juneteenth and PRIDE. We celebrated Race Amity Day where races joined in friendship and amity where we are reminded that we all need to show up together for everyone's freedom.

I celebrate you for showing up and being part of the LWVSPA.
