
### Volunteers Needed

## Voting Rights Restoration: Legal Training and Fines & Fees Clinic

On Dec. 12, we're cosponsoring a [Voting Rights Restoration legal training](#) and a [fines & fees legal clinic](#) aimed at helping more returning citizens regain their rights to vote.

The training will be held at Stetson University College of Law from 12-3 p.m. Lunch will be provided. Attorneys who complete the training will receive a two-hour CLE credit approved by the Florida Bar.

Afterwards, the attorneys who complete the training are invited to take part in a free legal clinic at Campbell Park Resource Center from 4-6 p.m. where they will help people navigate the process of ensuring all of their fees, fines and court costs are paid so they can register to vote. We'll also have voter registrars on site to help anyone register at that time.

If you or someone you know would be interested in utilizing the services of this clinic, please make sure to bring any documents or receipts you have related to your fines and fees.

This is a joint effort with the Leagues of Women Voters of Florida and North Pinellas County, the Community Law Program, Gulfcoast Legal Services, Stetson University College of Law, the Florida Bar Foundation, the Florida Rights Restoration Coalition and PERC.

## **Gun Safety**

The *Tampa Bay Times* recently published an [opinion article](#) by Dr. David Berman, a member of our gun safety action team and a pediatrician, highlighting our epidemic of gun violence and its impact on children.

["The Science of Gun Violence"](#) from *Discover* is a solid introductory article with authoritative and current data and findings. In exploring gun violence from a public health perspective, *Discover* reports on a recent analysis by RAND which found that only child-access prevention laws, such as those that require keeping guns at home safely locked, met their highest evidence-based standard for reducing injuries and deaths in children.

## **Immigration**

On behalf of the Pinellas Coalition for immigration Justice, we drafted letters that were sent from the Coalition to Reps. Gus Bilirakis and Charlie Crist, as well as Sens. Marco Rubio and Rick Scott.

Our request is to support the passage of a budget for the current fiscal year that began on Oct. 1, 2019. We also asked that the reporting requirements regarding the treatment of migrants that was passed as part of the July 2019 \$4.5-billion Supplemental Funding bill to address the crisis at our border with Mexico be carried forward into this year's funding.

## **National Popular Vote**

Two state legislators have made moves to support the National Popular Vote Interstate Compact: Rep. Joseph Geller sponsored HB335 and Sen. Victor Torres sponsored SB908. The NPVIC has been passed by 15 states plus the District of Columbia,

representing 196 of the 270 electoral votes needed to enact the law.
