President's Letter

Dear League Members and Supporters,

This summer has proven to be a busy one for the League of Women Voters at both the state level and in our own backyard of St. Petersburg.

At the state level, the League has demonstrated tremendous

leadership and successful results. One very important example is that in mid-July, 2nd Circuit Court Judge Terry Lewis ruled in favor of democracy and the citizens of Florida and set the path for Florida voters to elect their representatives in fair and constitutional districts. The Florida Legislature chose to ignore the voice of the people who voted overwhelmingly to approve amendments 5 and 6 in 2010 when they redrew the district maps behind closed doors, and without regard to the constitutionality of their decision. Judge Lewis's ruling ensures the legislature will adhere to the constitution.

We are thrilled to see justice being served. It is important for the Florida legislators to know that it isn't politicians who choose voters, but voters who choose their representatives. The timeline to redraw the maps is closing, and the secretary of state is working with local supervisors of elections to prepare a plan for a special election, pending further review by the judge. The League has made a difference, and we should all be proud of this accomplishment. It is a win for democracy!

Locally, we are in full swing registering voters, holding candidate forums, and educating citizens about the primary



Universal Curbside Recycling

City staff defined their requirements for the implementation of universal curbside recycling, but no vendors responded. This is a very embarrassing moment for St. Petersburg considering that all other major cities in Florida, as well as numerous smaller communities in our area, have curbside recycling.

Having observed this process for 15 months, our first question is: WHY? We would like to hear from the vendors, but we also suggest that objective outside expertise is needed to review the process to date and make recommendations on how to proceed.

This is an opportune time to look at the whole project, and we would like to point out aspects of basic project management that have been missing from this process, including the need to:

- 1. Establish, track, and report (quarterly for the first year and semi-annually in subsequent years) specific tonnage targets to address the primary goal of this project, which is to significantly increase St. Petersburg's recyclable waste.
- 2. Develop and manage action plans to ensure the over-arching goal and tonnage targets are met, and then share those plans with the public. The People's Trash Coalition has offered to assist with the associated marketing and education that will be required to meet these targets, as well as educating the public about proper recycling methods to reduce contamination.
- 3. Conduct an overall economic analysis that delineates start-up capital costs, ongoing operational costs, and anticipated revenue from selling recyclable waste based upon above projected tonnage targets. Include in the analysis a projected timeframe for reducing garbage collection to weekly and its resulting cost reduction.

We have not seen documentation of any of the above and are concerned that in their absence this project will continue to drag on and not reach its full potential.

Yes, the non-response from vendors is a major setback, but let's use this time to work together and develop a strong realistic plan that we can all agree to.

We expect universal curbside recycling will be on an upcoming City Council agenda in August, at which the League and other members of The People's Trash Coalition will testify. We will notify you

by email when we know the date and time. Please attend and bring a friend with you. Meanwhile-using the contents of this report--voice your concerns to the mayor and city council whose email addresses are: mayor@stpete.org and council@stpete.org.

We need your help. We got this far together. We need to remain involved to ensure that universal curbside recycling gets implemented effectively in St Petersburg.

Immigration

On August 6th, Sue Price and I, representing the LWVSPA Immigration Working Group, met with U.S. Congressman David Jolly and Stephani Lavely of his St. Petersburg office. The focus of our discussion was the LWV <u>position on immigration</u>, and we sought his support for:

- federal legislation that would significantly reduce the immigration backlog while meeting the economic, business, and employment needs of the US
- funds to treat the unaccompanied children at our southern borders as refugees

The League's position also supports federal policies to improve the economies, education, job opportunities, and living conditions in nations with large emigrating populations. The majority of the 57,000 unaccompanied children that have arrived at our southern border emigrated from Guatemala, Honduras, and El Salvador. The homicide rates in these countries are 54 per 100,000 people. However, in neighboring Belize, Costa Rica, Nicaragua, and Panama, the rate is 13 per 100,000. Nicaragua is the second poorest country in the region behind Haiti.

Our next working group meeting will be on October 15th at 10:00 am.



Voter Service

In addition to party primaries, the August 26th election offers all voters, regardless of party affiliation, the opportunity to weigh in on several atlarge and non-partisan races, such as School Board and Sixth Circuit Court Judicial. Voters will also determine the outcome on a county referendum (Economic Development Property Tax Exemptions for New Businesses and Expansions of Existing Businesses).

To help voters with their ballot choices, the North Pinellas County and the St. Petersburg Area LWV chapters have created the non-partisan *League of Women Voters* 2014 *Pinellas County Voter Guide*, your one-stop online election reference tool. In it you'll find:

- Candidate information including their responses (verbatim) to issue-based questions (races included: state legislative, 6th Circuit judicial, County Commission and School Board)
- Pros and cons on the primary ballot referendum
- Voter resource links

Check it out at <u>vote.lwvspa.org</u> and please share this link with those who might benefit from this handy resource, accessible for the first time on mobile devices.

Your Voter Service team is now planning activities for September and October in preparation for the November 4th general election to include:

- Distribution of LWVF State Voter Guides arriving in mid-September (including a Spanishlanguage edition) covering the following:
 - U.S. congressional races
 - Florida's state executive races
 - Florida's state legislative races
 - o Florida's state ballot amendments 1, 2 & 3
- Candidate forums
- A voter registration drive encompassing National Voter Registration Day on September 23rd. The deadline to register to vote in the general election is October 6th.

In Memoriam Evelyn Wright

Long-time LWVSPA member Evelyn Wright passed away peacefully on July 5, 2014. Evelyn was a League leader and an inspiration to all who worked with her over her many years of service to our League. We will greatly miss her indomitable spirit and "the significant contributions of an empowered, courageous, bright, focused, and informed woman."

It is impossible to capture all that she contributed to the LWVSPA, but some highlights of her League work--most in the words of her League cohorts--illustrate her importance to the growth and development of the LWVSPA:

- Served as League co-president, 2005-2007
- Served as nominating committee chair 2011-2012
- Served on charter school study committee in 2013
- Actively participated in the International Relations Working Group both as a facilitator and participant for many years
- "Evelyn opened her comfortable home to us over the years, and for several years hosted our program planning meeting and dinner at her home. A lot happened in her rooms!"
- "At the League 2005 convention, delegates decided to study the issue of alternative voting systems to determine if any alternatives to Florida's present system of plurality voting should be recommended. On behalf of the state League, the LWVSPA undertook a study of the many methods for tabulating votes and shared this accumulated background information with other local Leagues. Following statewide local League consensus meetings, the LWVF announced a new Election Law Voting Process position, making the method of instant runoff voting (IRV) a recommended alternative to plurality voting. Evelyn headed the LWVSPA study of IRV. As she always did when in charge of anything, she put heart and soul into the project."
- "When the path of least resistance was to delay getting a computer and associated new organizational and communication methods, she led the charge. If she hadn't, I think LWVSPA

- would have been too out-of-date to appeal to prospective younger members. I am grateful for her vision and courage."
- "When the second primary was being eliminated, she grasped the mathematical implications and possibilities. The event she organized to explain the complexities was engaging and memorable."
- "When there was a leadership crisis, she stepped into the breach. She was willing to try a new model as one of three people dividing the president's duties. When she embraced the plan, others agreed to give it a try. Where would LWVSPA be if she had been unwilling to innovate?"

Evelyn's memorial service was held on July 22nd at the Cathedral Church of Saint Peter. She had requested that donations be made to the Muscular Dystrophy Association, the Cathedral Church of Saint Peter music program, and the League of Women Voters of the St. Petersburg Area.

We extend our deepest sympathy to Evelyn's sister, Gladys Stifel, her daughter, Cheryl Shepard, and grandchildren, Aaron and Sarah Shepard.
