Dear League Members and Supporters,

Your League has continued to be active during the months leading up to summer. Here's a little bit about what's going on:

After the whirlwind of our fundraiser annual luncheon and election of officers and board of directors, our national convention in Dallas came to a close

with a closely contested election between our own state president, Dierdre Macnab and incumbent Elisabeth McNamara.

Florida sent all of its 75 voting delegates to support Dierdre in her vision for increased diversity and membership growth, innovation in program design and delivery, and inspired leadership. Elisabeth McNamara argued for staying the course, and continuity. Our own Susan Mayer and Darden Rice represented our local League as part of the feisty Florida contingent. The debate was intense, the program full, and the food, drink, and fun plentiful. Though not victorious in our national leadership quest, we start the year with a strong Florida state board led by Dierdre and a robust national, state, and local agenda.

This year, at the local level, we will join our State League in a focus on advocating for medicaid expansion, so that more than one million Florida residents, many working long hours to support their families, can get medical coverage and the care they need without risking their lives and life savings. The Florida legislature opens debate in early March 2015. We intend to be there, and to do what we can to ensure that health care coverage is available to as many uncovered residents as possible. 

We also take up the effort to educate residents on the pros and cons of Greenlight Pinellas, a referendum to increase bus service and lay the foundation for light rail in Pinellas County. And of course, our Voter Service Committee, led by Raechel Garafalo, is winding into full speed in its collaboration with our North County League partners to prepare a voter guide for primaries across the county. We will continue our efforts to educate residents on the importance of voting, proving information about candidates, hosting candidate forums, and registering voters. Primary elections occur on August 26th, and the deadline to register to vote is July 28th.

But while we're working, we want to have some fun, get to know our members, and invite others to join. 16 of us went to the Rays game on June 8th; we'll be at the Pride Parade; we'll show up at the Saturday Morning Market when it reopens in the fall; and we'll go to a happy hour or two. This year, we're also heading to Cuba, taking some trips in the Florida wild, and to "wild" Tallahassee, speaking up at public hearings, and participating in some educational trainings across the state.

Universal Curbside Recycling

Before beginning the procurement process for outsourcing the processing of recyclable waste here in St. Petersburg, city staff requested the results of Hillsborough County's study of contamination rates among their recyclables. On June 6th, Hillsborough reported the contamination rate at 18%.

The City of St Petersburg should now be ready to begin the procurement process for both the collection and processing of recyclable waste. We are anticipating an updated timeline for implementing universal curbside recycling.

We want the citizens of St. Pete to continue to remember the city's commitment and why we worked in coalition to achieve universal curbside recycling, starting with 76,000 single-family households. 
Voter Service

In preparation for the August 26th Primary Election, we are focusing this month's education efforts on judicial races. Part of that work includes distribution of a *Voter's Guide to Merit Retention*, published by the Florida Bar Association.

In support of that effort...we offer a **VOLUNTEER OPPORTUNITY**. The Voter Service team needs assistance in distributing the guides to

community centers (e.g., libraries, recreation centers, etc.). If you would like to help distribute this useful educational resource, please **contact me**.



Florida's judicial branch is composed of the Florida Supreme Court, five District Courts of Appeal, and 20 Judicial Circuits. Justices and judges on the Supreme Court and the District Courts of Appeal are appointed by the Governor upon the recommendation of the respective judicial nominating committees. At the end of their term, they may choose to place their names on the ballot for merit retention. Circuit and County Court Judges initially run for election, except in cases of a vacancy, when the governor appoints the judge.

There are 20 judicial circuits in Florida; Pinellas and Pasco Counties comprise the 6th Judicial Circuit, the third largest trial court in Florida. There are 69 judges (45 Circuit Court and 24 County Court) in the 6th Judicial



Circuit. Circuit courts have jurisdiction over controversies where the dispute has a value exceeding \$15,000, in family law, probate and guardianship matters and, on the criminal side, felonies. Jurisdiction in county courts is limited to controversies with a value of less than \$15,000, landlord/tenant disputes and, on the criminal side, misdemeanors and traffic violations. Cases are assigned to one of 13 divisions depending on the nature of the case and then randomly assigned to a judge in that division.

Judges to circuit and county court are elected for six-year terms. Judicial elections are scheduled this year for August 26th when the voters will elect five circuit court judges. There are no contested county court seats in this year's election.

Did You Know?



During the post-World War II period, the League helped lead the effort to establish the United Nations and to ensure U.S. participation.

The League was one of the first organizations in the country officially recognized by the United Nations as a non-governmental organization (NGO); *it still maintains official observer status today* and has special consultative status to the Economic and Social Council (ECOSOC).

The League also supported the creation of the World Bank and the International Monetary Fund, as well as NATO, economic aid to less developed countries and the Marshall Plan. For more information, <u>click here</u>.
