# **Voting Rights Restoration Working Group**

We Believe in 2nd Chances: Florida VotingRights Restoration by Stephanie Owens, 2nd VP and Chair, Voting Rights Restoration Action Group



InApril 2017, the Florida Supreme Court<u>approvedlanguage</u> for an amendment

that would automaticallyrestore voting rights to felony offenders, except those convicted of murder orfelony sexual offenses, upon completion of all terms of their sentence. TheLeague fully supports this amendment and is reigniting our efforts to help collectthe <u>petitions</u> needed toplace the amendment on the 2018 ballot. It's a daunting task. The initiative requires 800K signatures byJanuary 2018. We need your help. Please join the Voting Rights RestorationAction Group and help lead us to success.

The League is MakingDemocracy Work for Voting Rights Restoration, because:

- Florida is one of just three states thatpermanently bars ex-felons from voting unless they receive clemency.
- Today in Florida, the backlog forclemency applicants is over 20 years.
- 1.3 million Florida former felons have completed their terms of conviction. They will automatically have their voting rights restored when the amendment passes.

## **Immigration Working Group**



HomelandSecurity has Stepped-Up Enforcement by <u>Karen Coale</u>, LWVSPA Immigration Action Group Co-Chair & LWVF Immigration Committee Co-Chair

At our May planning meeting, we delved into two very relevantbut complex issues regarding immigration: *due process* and *expedited removal*. With the travelban and threats to sanctuary cities tied up in the courts, Homeland Securityhas stepped-up enforcement.

They have expanded the working definition of expedited removal from deporting recent arrivals (within 2 weeks) and within 100 miles of the border to anywhere in the U.S. and no time limits. This is why you are reading about so many arrests in the interior of the U.S. With the ramp-up in detentions, we question whether those being detained and deported are granted dueprocess.

As a first step, we are trying to understand what due process is, whois entitled to it, and under what types of law, e.g. civil, criminal, federal,state, etc. The latter is a constitutional issue which adds another layer ofcomplexity. We are educating ourselves in preparation for *Immigration Conversations* later thissummer--with a larger audience--and expanding our educational campaign on ourwebsite and social media.

We are also tracking at least three House bills. Two are on funding, with sizable increases in the \$18B range for U.S. Citizenship and ImmigrationServices and U.S. Immigration and Customs Enforcement, adding 10,000 personnel andstrengthening enforcement with upgraded weaponry.

The third bill HR2431 would direct state and local lawenforcement to divert their limited resources towards immigration enforcement, permit states and localities to pass their own immigration laws, and criminalizeunlawful presence of undocumented people in the United States. At present our sheriff does not respond to detention requests from ICE. This proposed lawwould require him to not only detain the undocumented, but to find them andarrest them. This is a really bad bill with far reaching consequences. So farit has only passed the House Judiciary Committee, but we are trackingit. We will mount an advocacy campaign to oppose this and otheranti-immigrant legislation via the LWVSPA weekly *Action Alerts*.

## **Reproductive Rights Working Group**

The next meeting of the Reproductive Rights Action Group will be at 7 pm on Thursday, July 2, at the Leagueoffice where **we will meet with Joanne Lentino, a Pinellas County SchoolBoard member** and member of our own LWVSPA. We will have a discussion about how sex education is approached in ourcounty and how we might work to broaden it to be more comprehensive to covercritical issues (e.g.



pregnancy prevention) and work to better educate studentsof all sexual identities and orientation.

We remain on highalert as the ACA replacement bill makes its way in the U.S. Senate and itsserious impact on women's health services. We urge continued pressure on SenatorMarco Rubio to vote down any replacement bill that jeopardizes health carecoverage for Floridians, especially those with few resources. Phone hisoffices, participate in public protests, send faxes, letters, postcards, andemails -- anything to get Senator Rubio's attention.

## **Education Working Group**



Despite strong opposition, Governor Scott signed the omnibuseducation bill 7069 as part of his grand dealwith the Florida Legislature leadership. Our Education Working Group is poised to monitor the impact of thebill's Schools of Hope policy, which would close struggling schools and handthem over to private charter chains. Wejoin the North Pinellas LWV Education Committee in our investigations

ofPinellas Schools and the Hillsborough County LWV in their in-depthinvestigation of for-profit charters.

We will also be monitoring the Constitutional RevisionCommission and its seeming desire to vastly expand the Florida Tax CreditScholarships, further diverting funds from public schools to unaccountable, largely religious schools.

At its recent State Convention, the LWVFL announced a state-wide effort to assistlocal chapters develop research and action plans that reach beyond ourmembership and form partnerships with parent groups, community groups, non-profits, etc.
