Universal Curbside Recycling

2014: It's Here! Universal Curbside Recycling Is On the Way to St. Petersburg

This past month the St. Petersburg City Council unanimously passed two resolutions regarding universal curbside recycling:

 To proceed with City Staff's recommendation to begin providing service this year to all 76,000 single family households in St Petersburg.



That outsourcing negotiations will adhere to the Local Hiring Ordinance and include a
living wage and benefits for all new hires under the contract. The Mayor also added
that he will ask City Staff to look into providing service to multiple family dwellings
and condos.

This is a major milestone in the campaign to bring recycling to all of St. Pete's households. At the meeting, over 60 people packed City Council chambers and wore "Recycle" stickers. This level of turnout makes a difference, and I thank you for your support.

It would also be helpful for each of you to send a thank you email to the <u>Mayor</u> for his support and your <u>City Council member</u> for their votes.

Our next steps include public education and awareness, providing a great opportunity for you to get involved. Our overall goal is to significantly increase recyclable waste in St. Pete, and an educated public is key to that success. Our project is called The People's Trash, and it is a coalition of partners including the Council of Neighborhood Associations, The People's Budget Review, The Suncoast Sierra Club, and the LWVSPA.

Chipping Away on Immigration Reform in Florida

The U.S. Senate passed a comprehensive immigration bill last June that meets many of the points in the League of Women Voters of the United States (LWVUS) <u>Immigration Position</u>. Despite some attempts, the U.S. House of Representatives has made no progress in producing immigration legislation.



However, within Florida, our legislators are making some progress, and we expect bills to be filed early in the session in these three areas:

- In-state tuition for students who attend for at least three years and graduate from Florida high schools and begin their college education within 24 months of graduation--regardless of their and their parents' immigration status.
- Undocumented youth who apply for and obtain the federal DACA (Deferred Action Childhood Arrival) status can use that documentation to obtain a Florida driver's license
- Kidcare bill that would allow a child who has a green card (Legal Permanent Resident status) to apply for Medicaid if the need exists. The current 5-year wait would be waived.

As the Florida legislative session begins, expect Action Alerts from the League of Women Voters of Florida (LWVF). Please do respond to them and make your voice heard.
