We will also be presenting **our first annual Babette Husick Community Action Award**, commemorating the memory of Babette Husick, devoted LWVSPA member, who supported the League in a bequest after her passing. This award recognizes an individual or community organization demonstrating commitment to working in collaboration with the League for change in the community in line with our principles and mission.

This year, it is our distinct pleasure to present the Babette Husick Community Action Award to our friend and colleague, <u>Gypsy Gallardo</u>: editor, publisher, organizer, and activist. Specifically, the League recognizes Gypsy's collaboration with the League on the get out the vote (GOTV) message. Because of her initiative, commitment, and collaboration, the League was able to get in front of ten congregations and to disseminate nearly 3000 Voter Guides directly to citizens we otherwise may not have reached. We are grateful to Gypsy, and want to recognize her contribution.

Please come and enjoy this afternoon with us.

We've also been busy beyond preparing for the new year. We sent five representatives to Tallahassee to participate in the League Lobby Days. We lobbied for Closing the Gap in Health Care, Immigration Reform, Gun Safety, Charter School Accountability, Environmental Conservation (Amendment 1) and assorted Voter Rights issues. And we had fun doing it.

As part of our advocacy campaign for Closing the Gap in Health Care coverage, we've met with more than 15 businesses and organizations, collected nearly 100 postcards to legislators, and completed countless emails, phone calls, and letters. We have a press conference scheduled to draw even more attention to this critical initiative on March 31st at 11:00 AM. We hope you will attend.

We are determined to get our legislature to pass a unique, flexible, Florida solution to take billions of dollars in federal monies and insure another million working Floridians, secure our health care economy, and get people the health care coverage they need.

Your efforts have been tremendous in this last month. There is much to do, and we are grateful to you for all of your efforts to make democracy work. As you know, the League is what you make of it. In addition to earning a Ph.D. from Florida State University, Jim completed a two year postdoctoral program funded by the National Institute of Mental Health in

Institutional Racism. He is an avid gardener of Florida native plants and an outdoorsman.

#### Kathy Mossing, Two-Year Term

Kathy served as an appointed member of the LWVSPA Board of Directors for the 2014-2015 term. She is a native of NW Ohio and a registered nurse. She spent most of her 44-year career in the Seattle area working in the areas of management, education, and administration. Kathy's last administrative position was at Virginia Mason Medical Center in Seattle. During her career she was very active in the Northwest Organization of Nurse Executives and is a past president of the Psi Chapter of Sigma Theta Tau, a nursing honorary society. ## **Recommended Bylaws Changes**

At its March 3, 2015 meeting, the Board of Directors passed the following motion from the Bylaws Committee to recommend for approval by the membership the following changes to the LWVSPA Bylaws:

That **Article VIII. Financial Administration**, **Section 2. Dues**\* be stricken from the bylaws in its entirety and replaced by a new Section 2 that states:

#### (AMENDED BYLAWS)

#### ARTICLE VIII. FINANCIAL ADMINISTRATION

Sec. 2. Dues.

a) Annual dues shall be set at the Annual Meeting by vote of the membership and shall be due and payable on or before each member's anniversary date. Approval of dues shall include creation of dues categories with differing levels of payment recommended by the Board. [04/15]

(b) Dues are paid by new members when they initially join the League, which becomes their anniversary dates. [04/15]

c) Any member whose dues have not been received by two months after their anniversary date shall be dropped from membership on that date. [04/15]

(d) During the first year of transition to anniversary date renewals, dues will be pro-rated based on last payment date. [04/15]

#### (CURRENT BYLAWS)

#### \*Sec. 2. Dues.

(a) Annual dues shall be set at the Annual Meeting and shall be due and payable on or before October first. [04/07]

(b) Dues paid by new members joining between July first and October first shall be credited to the ensuing League year. [04/07]

(c) Any member whose dues have not been received by December 31st shall be dropped from membership on that date, unless this action is countermanded by the board of directors. [04/07](d) When two or more members reside at the same address in a common household, full payment of dues shall be made for the first member; a payment equal to one-half the annual dues payment shall be made for each other member.

## 2015-2016 Budget
