On March 15, 2022, there are municipal elections in the following communities: Belleair, Belleair Beach, Belleair Bluffs, Clearwater, Madeira Beach, Oldsmar, Redington Beach, Redington Shores, St Pete Beach, and Tarpon Springs

Here's what's on the ballot:

- Mayoral elections in Belleair Beach, Oldsmar, and Tarpon Springs
- Council Members/Commissioners in Belleair Beach, Belleair Bluffs, Clearwater, Madeira Beach, Oldsmar, Redington Shores, St Pete Beach, and Tarpon Springs
- City Charter Amendments in Belleair, Madeira Beach, Oldsmar, and Redington Beach
- Referendum Questions in Madeira Beach and Redington Beach

Make sure your vote counts!

There are two ways to vote in the March 2022 municipal elections in Pinellas County:

- Vote in-person at your polling place on Election Day. Polls are open from 7:00am to 7:00pm on March 15. You can use <u>this tool</u> on the Supervisor of Elections website to find your polling place. Remember to bring <u>photo/signature ID</u>!
- Vote by-mail and return your signed ballot by 7:00pm on Election Day. You can either mail your ballot back to the Supervisor of Elections office, or you can drop it off at one of the three <u>Supervisor of Elections offices</u>. Just make sure it gets there before 7:00pm on Election Day!
